The Dominican Government, through the Government Office of Information and Communication Technologies (OGTIC), implements the Index of Use of ICT and Implementation of Electronic Government in the Dominican State (iTICge), with the aim of systematically evaluating the Efforts made and in progress, regarding the implementation of ICT and e-Government solutions focused mainly on the citizen services, internal efficiency and transparency in public institutions in the Dominican Republic.

The 4 pillars on which the iTICge is based are:

ICT use: assesses the availability and good management of human and technological resources, as well as the existence of controls for a good management of these resources

Implementation of e-Gob: evaluates the use given to human and technological resources for the implementation and monitoring of standards and national and international best practices, institutional web presence, transparency, open data, interoperability and interaction with the citizen through social

Open Government and e-Participation: evaluates the level of citizen participation in public policies using electronic means and the empowerment they have to exercise that right. In addition to the publication of open data by the institutions and the compliance with the NORTIC A3 standard.

Development of e-Services: measures the level of development of citizen services in each of the government institutions and verifies which Institutions have their catalog of online services as well as the level of progress of said services.
